4-2 Summary for the Annual Report:

The board held three meetings to specifically discuss the logistic for the revision of the ICOMOS "Guidelines for the Conservation of Monuments, Ensembles and Sites". Discussions took place to evaluate the relevance of the 1993 Training Guidelines, and it was considered that this document is not obsolete in what it discusses, but it does not cover some new issues, which have emerged since its adoption. Therefore, the 1993 Document was proposed to be kept as an historic document and valid in the issues it deals with. As well, two meetings were held with the Working Group to confirm the workprogram and approach.

The CIF Guidelines Working Group is comprised of Jurate Markevičiene, Teresa Patricio, Carlo Cesàri, Jukka Jokilehto, Navin Piplani and Lyse Blanchet directs and coordinates the development of the document titled: *Principles for Capacity Building through Education and Training for the Safeguarding and Conservation of Cultural Heritage*; this work would be carried out in conjunction with ICCROM represented by Joe King. It was also decided to establish sub-working groups for drafting Guidelines for the specific target groups. A first draft Sub-Document for Professionals had been developed by CIF-UK and was further discussed. It was then decided that the CIF-UK would develop a template document for other such Guidelines. A first draft Sub-Document for Practitioners has been developed and will sent for comments in 2014.

6 Heritage Alerts and Heritage@Risk

The Committee has not been involved in this publication; however, the NEW Principles under development will introduce the concept of risk awareness and preparedness. 
